1. 23/24 Top-up Funding

1.1 At the start of the financial year, a report is generated by the Finance department to determine the 23/24 EHC commitments for each mainstream school in Lincolnshire. See example below.

Columns A and B - Identifies the child with the EHC. Date of Birth and Mosaic Number will also be included

Columns C and D – Identifies the period of agreement for the EHC. For funding purposes, the start and end dates are rounded to the nearest whole month e.g. an EHC agreed on the 10^{th} of April will be funded from 1^{st} April, and an EHC ceasing on 20^{th} April, will have a funding end date of 30^{th} April. In most instances, the date in column D will reflect the end of the Academic Year in which the child is due to leave school. However, the end date may be earlier, if the EHC has ceased, or the child has transferred to another setting or county. The funding end dates will also cease based on the (rounded) date when the child leaves school, or has a plan ended/amended.

Column E – This indicates the level of hours assigned to the EHC for the basis of the top-up funding calculation. The main 4 bands are as follows:

Mild = 17.5hrs Moderate = 20hrs Significant = 25hrs Profound = 32.5hrs Please Note – These hours are for funding purposes only and do not reflect the actual number of hours schools are expected to provide support

Column F – Indicates the number of months for which the child's EHC requires funding in the 23/24 financial year i.e. Apr 23 to Mar 24.

Column G – Indicates the level of notional funding¹ that the school will be required to contribute. See **23/24 Targeted Funding** section for details of when the authority will contribute towards this cost.

¹ Notional Funding forms part of a mainstream schools' budget share and derives from the school's block of a Local Authorities' dedicated schools grant.

Column H – This details the total funding attributable to the EHC. For Will Nightingale, it is calculated as follows:

Hourly Rate x Number of weeks in the year x Level of EHC/hours i.e. £11.84 x 52.14 x 20 = £12,346.75

For 23/24, the hourly rate has been increased to **£11.84**. The hourly rate will continue to be reviewed each year in line with government changes, whilst assessing affordability of the overall High Needs Block.

Column I – This details the authority's annual top-up funding contribution to the school i.e. Total funding (column H) less Notional Funding (column G).

1.2 In the above example, the school is entitled to £22,126.94 top-up funding for the 23/24 financial year. This will be allocated on a monthly basis to the school i.e. £22,126.94 / 12 = £1,843.91 per month (this will be actioned via a recharge for maintained schools). This amount will be allocated every month from April to July. Therefore, the school will have received £7,375.64 by the end of July 23.

1.3 In August 23, the authority refreshes the report of school EHC entitlements. If there is no change to the EHC entitlements, then the school will continue to receive the same monthly top-up allocation (that they received from April to July) from August 23 to December 23. However, the example below provides the detail on how the monthly top-up figure may differ if the EHC entitlements change.

As the new student's EHC did not start until June 23, the top-up funding entitlement is from June 23 to March 24 (10 Months) and the notional funding the school is required to contribute is 10/12th of £6,000 i.e. £5,000.

Therefore, the total funding for the new student is £11.84 (hourly rate) x 52.14 (weeks in a year) x 32.5 (hours assigned to a 'Profound' band) x 10/12 (June 23 – March 24 i.e. 10-month's funding) = £16,719.56.

Less the school's contribution of notional funding i.e. £16,719.56 - £5,000.00 = £11,719.56 top-up

1.4 As funding has already been paid for April to July which totalled \pm 7,375.64 (\pm 22,126.94 x 4/12th) the monthly amount received by the school is then recalculated as follows:

Revised total top-up entitlement (£33,846.50) less the paid to date figure (£7,375.64) = £26,470.86 and this will be split equally between the 8 remaining months from Aug 23 – March 24 i.e. \pm 26,470.86 / 8 = \pm 3,308.86 per month.

1.5 Following the Aug 23 update, the next time the EHC entitlement report is refreshed, is in January 24. Again, if there are no changes from the Aug 23 entitlements, the monthly amount will continue to be paid for Jan 24 to Feb 24. Any changes in top-up entitlements will again be re-calculated as per the example below

1.6 As Ollie Palmer left at the end of November his funding will be recalculated as 20 hours for 8 months (April 23 - November 23) i.e. £11.84 x 52.14 x 20 x 8/12 = £8,231.17

The Notional Funding is also recalculated as £6,000 x 8/12 = £4,000

The actual January 24 top-up allocation is then recalculated by taking the new total annual top-up entitlement and deducting any top-up funding that has been allocated to date (from Apr 23 - Dec 23), before dividing the outstanding balance equally across the remaining three months (Jan 24 - Mar 24).

e.g. £31,730.92 - £23,919.94 ((4 x £1,843.91) + (5 x £3,308.86)) = £7,810.98

£7,810.98 / 3 = monthly payments of £2,603.66 from Jan – Mar 24.

1.8 The authority does refresh the 23/24 EHC top-up entitlement report again both in March 24 and June 24, and any changes due resulting from this revised information are paid in full in those months.

Any financial arrears top-up payments due as a result of backdated funding owed for previous financial years will also be paid in full (and identified separately on any remittance) as part of the update in which they have been identified.

Should the level of funding paid ever exceed the value of the EHC top-up funding due to the school at any of the updates, then the authority will either raise a sales invoice to reclaim the value of the overpayment in the case of academies or Prime Account schools, or action a recharge if the overpayment relates to a maintained school.

2. 23/24 Targeted Funding

2.1 It is a local decision to have targeted funding. Lincolnshire is fully supportive of the inclusive approach, and therefore apply a targeted funding criteria (which is supplementary funding to the schools national funding formula) to ensure that schools are not being financially disadvantaged by having a disproportionate number of pupils with more complex needs.

Targeted funding is calculated based on whether an individual school is adjudged to have an adequate level of Notional SEN within their budget share for the number of EHC's they currently have.

2.2 Targeted funding is automatically triggered when a school's Notional Funding EHC requirements exceed the value that is equivalent to 30% of the Notional SEN in their original Budget Share. This percentage was established prior to the delegation of funding for School Action and School Action Plus and bands 1-5 statements, therefore reflected the full spectrum of support to be delivered through Notional SEN. Below is an extract of where that figure can be located within the budget share publication.

2.3 In the example above, the £75,596 is not a separate allocation that is made to the school, but a notional figure that is calculated using the percentages of the formula factors in the table below. This demonstrates the total amount of notional funding already within the school's budget to be used to help fund all additional needs pupils, namely, low level high incidence SEN and to fund the first £6,000 for pupils with an EHC from this figure.

From prior funding SEN-related delegations to schools, the national funding formula provides 4.89% of the total AWPU value for every Primary School, and 4.75% / 4.79% for every Secondary for 'notional SEN', which in this example, equates to £21,221.

2.4 Lincolnshire's notional SEN funding for mainstream schools overall within its delegated budget shares is 11.4% for 2023/24. This is in line with the prior two years of 11.5% and 11.6% for 2022/23 and 2021/22 respectively. The ESFA analysis of Local Authorities Schools block funding formulae (July 2020) showed 79% (119) of Local Authorities assign between 5% to 15% of Schools block funding to notional SEN, and c.35 Local Authorities within the 10% to 12.5% category. The overall percentage across all Local Authorities being 11.4%. This provides re-assurance that the general percentages being applied are broadly in line with other local Authorities.

To determine if the school will receive any targeted funding, the notional funding figure of £75,596 x 30% is calculated. In this example, this equates to £22,678.80. This is the contribution the school will be required to make from their notional funding allocation before any targeted funding is allocated. As the EHC notional funding requirements of the school equate to £18,000, this means that the school would not trigger any targeted funding at this stage.

2.6 As per the top-up arrangements, any annual entitlement for targeted which has been identified at this stage of the year, would then be split evenly, and paid each month across the 12-month period. Targeted funding is paid separately to top-up, so that each can easily be identifiable when schools reconcile their monthly adjustments.

2.7 Naturally, as the EHC annual top-up entitlements change at each of the updates we perform, so can the targeted. Therefore, based on the top-up funding example data, please see a breakdown below of how this would affect the monthly targeted payments due.

In the example above, a sales invoice would need to be raised in Jan 24, reclaiming the £200.75

3.2 For secondary schools, there will also be a separate list of Post 16 student entitlements. Please note that schools are not expected to fund the first £6,000 for Post 16 children; therefore, the authority funding entitlements for these children are represented by the Total Funding column (not the top-up column). Post 16 students will also not form part of any targeted funding calculation.

5. Funding for OLEA Pupils

5.1 In the event that a Lincolnshire school admits a child resident in an 'Other Local Education Authority' (OLEA), it will be the school's responsibility to recoup the top-up funding for that child direct from the other authority.

Adjustments to transfer the notional funding for OLEA pupils should be made as part of the ESFA's import / export publication, therefore Lincolnshire should be in receipt of the £6,000 for these children. Therefore, if schools are already triggering targeted funding (or would have triggered it had the OLEA child been placed by Lincolnshire), then they should contact the authority (Lincolnshire) in order to be reimbursed with this cost at the end of the financial year (March).

5.2 Targeted funding for children in care (LAC) to another authority can however be claimed direct from the OLEA (as well as any top-up), as these children do not form part of the ESFA's import / export adjustment, and therefore the £6,000 notional funding will have remained with the placing authority. Schools should be holding conversations with other authorities to confirm their funding responsibility at the outset, not once the child is placed. Lincolnshire has received official confirmation direct from the ESFA regarding this matter, therefore, in the event of any authorities challenging this contribution; the extract below should be included in any request for targeted funding.

5.3 In cases where a LAC who is the responsibility of another local authority, but who is resident in Lincolnshire, and for whom Lincolnshire County Council maintains the EHC plan, it would be possible for the Council to include any relevant targeted high needs funding, along with the top-up funding, in a recoupment request to the other authority under the 2013 regulations.
