## Christmas is the time for giving – but not infections!

## **Prevention of Infectious Illnesses**

Respiratory infections are common in adult social care settings and amongst older adults, particularly during the winter months. Symptoms can be caused by several respiratory infections including the common cold, COVID-19 and Respiratory Syncytial Virus (RSV). Older people and those with chronic illnesses are particularly at risk of developing more severe illness and complications from certain infectious diseases. The risk from many of these diseases, such as COVID-19, flu, pneumococcal infection, RSV and shingles, can be significantly reduced through vaccination. It is therefore important that eligible residents as well as older adults living in their own homes, are given the opportunity to protect themselves through vaccination. This also reduces the likelihood of outbreaks in a care home. Cold weather can also put people at greater risk of ill-health because it increases the probability of complications from existing disease, and of injury due to falls.

We have started to see an increase in respiratory illnesses in the past couple of weeks with a higher than usual attendance at Emergency Departments and Urgent Treatment Centre's. If you are concerned about someone that you visit in their own home, you can get advice from their GP or 111.

Here are some small steps, settings and domiciliary care workers can take to minimise the spread of respiratory illnesses and other infections this winter:

- Hand hygiene hand hygiene between tasks and between service users with soap and water or alcohol-based hand rub. Please note, alcohol-based hand gel is not effective at killing the germs that cause norovirus and, in these cases, should not be used.
- **Promote respiratory etiquette and cough hygiene** covering the nose and mouth when sneezing and coughing can reduce the spread of infections.
- **Cleaning** Cleaning of shared equipment, especially after use. Enhanced cleaning should be introduced when there is an outbreak, to reduce further transmission.

- **Ventilation** Introducing fresh air into indoor spaces can help dilute air that contains virus particles and reduce the spread of respiratory infections. During the colder months, it is a good idea to open windows when rooms are unoccupied.
- **PPE** Appropriate use of personal protective equipment. More information about PPE requirements when caring for someone with suspected or confirmed acute respiratory infection can be found <u>here</u>.
- Waste Correct handling and segregation of waste and infectious linen.
- Vaccinations COVID-19 vaccines are also available for health and social care workers to protect staff from serious disease and social care services from staff absences over winter. Frontline social care workers, including both clinical and non-clinical staff who have contact with people with care and support needs, should also be made aware of the flu vaccination offer, when available, by their employer. - Care home resident transfer forms Please ensure that when transferring a resident to a different setting, you use a transfer form which details the current infection risk for the resident. This will allow the receiving organisation to take appropriate measures when receiving someone into their care.
